Ordinance 1327: a golf cart may be driven on city streets posted 35 mph or less, sunrise to sunset, with a permit tag visible from the front, a slow-moving-vehicle emblem, a rear-view mirror and windshield. The driver must be over 16 with a valid license and proof of insurance meeting Minn. Stat. 65B.48. The Police Department reviews applications at 719 2nd Street.

Fee: \$40 registration; \$20 annual renewal. Permits run one year.
